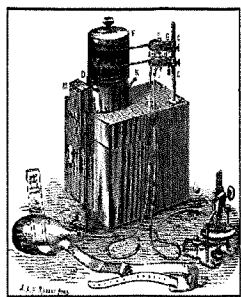

I conducted a psychophysiological detection of deception polygraph examination on Aaron von Ehlinger, at the Morgan Polygraph suites located at 6126 W. State Street, Boise, Idaho, 83703.

This polygraph was conducted at the request of Attorney Scott McKay and the purpose of the polygraph examination was to assess Aaron's veracity concerning allegations that he engaged in sexual contact with a woman without her full consent.

This matter has been, or is being, investigated by the Idaho House of Representatives, the Idaho Attorney General's Office and the Boise Police Department.

The polygraph examination consisted of three phases:

- pre-test interview,
- examination phase
- post-test interview.

A brief pre-test summary of the case (according to Attorney McKay, Aaron von Ehlinger and my review of attached official reports) is as follows:

Aaron von Ehlinger (hereafter referred to as Aaron) is a Representative in the Idaho House of Representatives. [REDACTED] (hereafter referred to as [REDACTED]) is a [REDACTED] with the House of Representatives, although she is not assigned to assist Aaron as a part of her duties.

[REDACTED] has alleged that in March, 2021, she and Aaron engaged in sexual contact against her will. [REDACTED] further alleged that on different occasions, Aaron gave her money to pay for gas, let her keep the change from money he gave her for lunch and bought her lunch.

[REDACTED] alleged that one night she met Aaron in downtown Boise, where she rode in his car to the Barbacoa Grill, where they had dinner. She alleged that following dinner, she and Aaron went to his apartment. At that location, [REDACTED] alleges that she engaged in sexual contact (fellatio) with Aaron, but no allegation was made of sexual intercourse. [REDACTED] alleged that at one point she told Aaron "No" and she alleged that she was intimidated by him because he carries a gun. She also stated that she felt she couldn't refuse Aaron's sexual advances due to a power differential between his status as a Representative and hers as [REDACTED]

During our pre-test interview, Aaron stated the following:

- He acknowledged that he and [REDACTED] did engage in consensual sexual contact in his apartment.
 - The sexual contact he referred to was, kissing, fondling of breasts, kissing of her breasts, manipulation of his penis by her hand and fellatio.
- [REDACTED] was a willing participant in all of the sexual contact described above.
- He has never supervised, or directed the activities of, [REDACTED] in her role of [REDACTED] for the House of Representatives and she is not assigned to him as his [REDACTED]
- He has never given [REDACTED] money for any reason; has not bought her lunch, never let her keep money from her getting lunch and never gave her gas money.
- He never used force, fear or coercion to persuade or make [REDACTED] engage in any form of sexual contact.

I constructed a simple Interview Route Map, to aid the testing process (see attached). This map is designed to remove ambiguity from the polygraph interview process by providing an operational definition of terms. In this case, the mind map gave a visual explanation for the terms "Verbal Indicators" and Non-Verbal Indicators" in the non-consent category. This provided an operational definition of those terms when they were used in polygraph questions.

Examiner and Instrumentation:

I am a graduate of The Backster School of Lie Detection and I am a Certified Forensic Law Enforcement Polygraph Examiner (Certificate #1646), said certification being issued and administered by the American Association of Police Polygraphists.

I am a full member of, and instructor for, the American Polygraph Association, the American Association of Police Polygraphists, the National Polygraph Association and the Idaho Sex Offender Management Board (SOMB).

The examination was conducted utilizing a computer polygraph system, which combines conventional polygraph procedures with computer graphics display and processing.

All physiological responses were monitored during the presentation of the questions by means of a Lafayette LX-6 polygraph instrument. The instrument serial number is 200669D3. The scoring method utilized for this examination was the Empirical Scoring System (ESS).

Testing Methodology:

At the conclusion of the pretest interview, an acquaintance test was conducted. That procedure was designed to demonstrate to the subject and to me that they were a suitable subject for a psychophysiological detection of deception examination. Adequate recordings of the subject's physiology were obtained during this procedure, so the examination continued.

A comparison question test was then conducted using validated testing methods. The Utah Technique, which is numerically scored, was utilized for this examination. This format is based on the criteria and procedures developed and validated at the University of Utah. This method of evaluation was the subject of numerous scientific studies and represents the evaluation method with the strongest scientific validation. Data from at least 3 presentations of the questions were obtained and were subject to numerical scoring.

The data was also analyzed by two computer scoring algorithms, called the Empirical Scoring System (ESS) and the Objective Scoring System, Version 3 (OSS3). The computerized test data analysis agreed with my professional scoring of the data and the results are incorporated in this report.

This series of testing was conducted using an **Evidentiary** standard.

The results were scored from the following traditional physiological parameters:

- * Pneumo - Respiration - Two input channels
- * EDR/GSC – Electro-Dermal Response/Galvanic Skin Conductance
- * Cardio - Rate, Strength and Amplitude from two different indices
- * Movement sensor on subject chair

Together with Aaron, I formulated the following relevant questions:

CONCLUSION:

Chart Analysis: No Reactions Indicative of Deception

Professional Opinion:

I believe that the examinee Aaron von Ehlinger is being **Truthful** to the tested issues.

Aaron von Ehlinger showed no significant reactions to the relevant questions detailed above. The absence of significant reaction is consistent with truthfulness and this examinee should be regarded as being truthful to the tested issues.

I submitted this data to be analyzed under the Empirical Scoring System and Objective Scoring System algorithms and those analysis agreed with my professional opinion of No Deception Indicated.

Preface: I was asked to give a written statement concerning information conveyed to me by Idaho House of Representative [REDACTED]. My relationship with [REDACTED] started in January 2020, when she was a [REDACTED] and I was the Asst. Sergeant at Arms for the House of Representatives. Part of my duties was to oversee the [REDACTED] during the Legislative Session.

[REDACTED] came to me around 8:20 a.m. on the morning of March 11, 2021 and asked if she could talk to me in private. We went to an area where we could talk. I asked her what was going on and she was clearly upset and began telling me that she had gone to dinner last night with a person and something had happened and she wasn't sure what to do. I asked her to be specific and start at the beginning. She said it started with this person being nice to her at work. He gave her \$40 to go get him lunch and when she came back with the lunch, he told her to keep the change. She said it was nice because it helped her pay her Les Schwab bill. On other occasions, he would bring her lunch and paid to fill-up her car with gas. On the night of March 10, 2021, she met him in downtown Boise. She got in his car and he took her to the Barbacoa Grill for dinner. She said he was a gentleman and opened the doors for her and they talked about her life and stuff. After dinner, they went back to his apartment and he left to go put something in his car. She started talking to me about him having an erection. She didn't say what happened between him leaving to go to his car and her seeing he had an erection, but she said she still had her coat on. She said she froze when the sexual contact started and didn't know what to do. He said this shouldn't scare her because she was already [REDACTED]. He started taking her clothes off and then she said he had his penis in her mouth and ejaculated on her. I asked her if she told him "No" at anytime and she said she did. She said to me "you know he has a gun". She said he relayed an incident in the past where a Legislative Representative said something inappropriate to a [REDACTED] and a big deal was made of the comment. He told her he wasn't going to tell anyone. She then said that the person she was with last night was Rep. von Ehlinger.

After hearing what [REDACTED] had just told me, I said "You must want me to help you or you wouldn't have come to me and told me of this encounter". She told me that she was afraid to be around him. I asked her "Do you want to report this?". She said she was afraid and didn't know what to do. I said "[REDACTED] you must be uncomfortable with what happened last night or you wouldn't have come to me and now you are saying you are afraid to work around him. I will help you report this incident through the proper channels, but you will need to tell your accounting of what happened to someone that will help you. Do you want me to report this?" She said yes. At that point, she told me to wait and she hurried off. She didn't immediately return so I headed back to my office. I came across her coming out of the bathroom and she said she had just thrown up. I asked her again "You want me to report this, correct?" and she said yes. She went back to her work area and I immediately informed the Speaker of the House, Scott Bedke of my conversation with [REDACTED].

I believe this to be a true and accurate accounting of my conversation with [REDACTED] on March 11, 2021.

As Chairman of the Ethics and House Policy Committee, it is my duty to inform you that a formal ethics complaint has been filed against you. The allegations in the complaint state that you have potentially engaged in conduct unbecoming of a Representative which would be detrimental to the integrity of the House as a legislative body under House Rule 45(2)(b)(i). As per House Rule 45(2)(d), The Ethics and House Policy Committee met and has determined that the complaint is valid, and is proceeding with the course of action as outlined in House Rule 45(3). Upon delivery of this notice, you have up to fourteen days to provide a written response to the Committee, via the Chairman, per House Rule 45(3).

As of now, the complaint remains confidential. I suggest you make yourself familiar with House Rule 45, which contains the House Rules regarding ethics, in order to understand the process more clearly. While these are not legal proceedings, you are able to seek legal representation, and to use counsel throughout the proceedings, should you wish to do so.

You will find a copy of the complaint, as well as evidence supporting the complaint, enclosed with this letter.

Dear Chairman Dixon:

On March 11 a complaint of inappropriate sexual conduct involving [REDACTED] and Representative von Ehlinger was reported to the Speaker of the House by the Assistant Sergeant at Arms, Kim Blackburn. Upon receipt of this information, it was immediately reported to the Attorney General's Office, who interviewed Ms. Blackburn and determined that the encounter may have violated the House of Representatives Respectful Workplace guidelines. At that time, the Attorney General's Office referred this matter to law enforcement for a possible criminal investigation. An investigation by the Boise Police Department was commenced. On March 12, House Majority Leadership was briefed regarding these allegations. On advice of the Attorney General's Office, no further action was taken by the House Majority Leadership at that time in order to prevent interference with the criminal investigation. On March 16, House Majority Leadership was informed that the law enforcement investigation would not be moving forward at the request of [REDACTED]. Based upon the complaint being brought to our attention, and now that it appears that we will no longer be interfering with an ongoing investigation, we feel compelled to bring this complaint before the Ethics and House Policy Committee.

We, the undersigned, bring a complaint alleging that Representative von Ehlinger has possibly engaged in conduct unbecoming a Representative which would be detrimental to the integrity of the House as a legislative body under House Rule 45(2)(b)(i). Due to the severity of the allegations contained within the complaint, we are referring this matter to the Ethics Committee. It has been alleged that Representative von Ehlinger used his position as a member of the House of Representatives to initiate a sexual encounter [REDACTED] of the House of Representatives.


Within the complaint made to the Assistant Sergeant at Arms, it is alleged that Representative von Ehlinger took [REDACTED] to dinner. Following dinner, Representative von Ehlinger took [REDACTED] back to his apartment, saying he had to stop by for something that he had forgotten. [REDACTED] accompanied him up to his apartment. The details of what occurred next are unclear, but at some point, Representative von Ehlinger is alleged to have initiated a sexual encounter with [REDACTED]. [REDACTED] reported that at some point she said "no" to the encounter.

According to the allegations within the complaint, [REDACTED] did not want this to occur. It is further alleged that she felt she could not refuse because of the power differential between Representative von Ehlinger as a member of the Idaho House of Representatives, and her as a [REDACTED]. It is also alleged that [REDACTED] was also fearful because she believes that Representative von Ehlinger carries a gun at all times.



The above actions constitute the basis for this ethics complaint. Thank you for your prompt attention to this matter.



Summary of Analysis							
<p>Recorded physiological data were evaluated with the Empirical Scoring System (ESS-M). The ESS-M is an evidence-based, standardized protocol for polygraph test data analysis using a Bayesian classifier with a multinomial reference distribution. Bayesian analysis treats the parameter of interest (i.e., deception or truth-telling) as a probability value for which the test data, together with the prior probability, are a basis of information to calculate a posterior probability. The multinomial reference distribution is calculated from the analytic theory of the polygraph test - that greater changes in physiological activity are loaded at different types of test stimuli as a function of deception or truth-telling in response to relevant target stimuli. The reference distribution for this exam describes the probabilities associated with the numerical scores for all possible combinations of all possible test scores for all recording sensors.</p> <p>These results were calculated using a prior probability of .50 for which the prior odds of truth-telling were 1 to 1. A credible-interval (Bayesian confidence interval) was also calculated for the posterior odds of truth-telling using the Clopper-Pearson method and a one-tailed alpha = .05. The credible-interval describes the variability of the analytic result by treating the test statistic (posterior odds) as a random variable for which the limits of the credible interval can be inferred statistically from the test data. A test result is statistically significant when the lower limit of the credible interval for the posterior odds has exceeded the greater value of the prior odds or the required minimum cut-ratio.</p> <p>The categorical test result was parsed from the probabilistic result using two-stage decision rules. Two-stage rules are based on an assumption that the criterion variance of the test questions is non-independent, and make use of both the grand total and subtotal scores. The grand total score of 14 equaled or exceeded the required numerical cutscore (3). These data produced a Bayes factor of 20.1. The posterior odds of truth-telling was 20.1 to 1 for which the posterior probability was .95. The lower limit of the 1-alpha Bayesian credible interval was 8 to 1, which exceeded the prior odds (1 to 1). This indicates a likelihood of 95% that the posterior odds of truth exceed the prior odds. These analytic results support the conclusion that there were NO SIGNIFICANT REACTIONS INDICATIVE OF DECEPTION in the loading of recorded changes in physiological activity in response to the relevant test stimuli during this examination.</p>
